In February Lea will meet with the Regional LGA Executive Officers as a group and discuss the long term changes and that will inform LGTAP initially. Any substantive changes will need to be organised for the 2022/23 round.

The Panel agreed that an Implementation Plan should be put together prior to engagement with the Regional LGAs. The Plan will need sign off through the Grants Commission prior to LGA Board sign off. Once feedback has been received from all parties, we can then move to the Implementation Plan, starting with a new funding agreement.
